Author/Vendor Agreement

Participation and Promotion:

By attending any event hosted by Lucky Mountains Events as an author or vendor you agree to promote the event to your readers and/or clients via social media and newsletter communications leading up to the event. Graphics and ad copy will be provided for your use.

Participation on signing day requires your attendance at your table during the entire stated hours for the event. By agreeing to attend you are also agreeing to this time frame.

Book Signing / Sales:

Attending Author/Vendor is responsible for handling all aspects of book or merchandise sales. Attending Author/Vendor is responsible for all Monies and Taxes collected from the sale of said items.

If the Attending Author/Vendor has pre-order forms — via Google Form, Beventi or other online form or ordering system — they can utilize this route to sell product in advance. Agreements must be fulfilled by the end of the book signing.

Event Payment Policy

Deposits and Payment Schedule:

If you choose not to pay in full at the time of this agreement, you will not be announced as an Attending Author/Vendor until a partial or full payment is received at the discretion of Lucky Mountains Events.

Invoicing for payment arrangement:

Invoices will be sent to the PayPal email address on file upon receipt of registration information. Payment terms and due dates will be specified in your invoice.

Forms of payment:

As specified in the PayPal invoice.

Tickets, table fees, and deposits are non-refundable.

Clauses

Anti-Harassment and Non-Discrimination Agreement:

Attending Author/Vendor agrees to the anti-harassment and non-discrimination agreement found on our website and to uphold the name and good nature of the event and its attendees.

Force majeure (Act of God):

In the event of a tornado, earthquake, hurricane, pandemic or any other type of weather or natural disaster requiring the event to be rescheduled, any funds paid will be applied to the future conference date.

Indemnification Clause:

Attending Author/Vendor shall defend, indemnify and hold Lucky Mountains Events and its Indemnitees harmless from and against any and all claims, actions, damages, expenses (including reasonable attorneys' fees), losses or liabilities incurred by or asserted against us or any of its Indemnitees for injury (including death) to persons or damage or destruction to property and any and all fees, costs, or penalties incurred by Lucky Mountains Events or any of its Indemnitees, to the extent that such claims, actions, damages, expenses, losses, liabilities, fees, costs or penalties are caused by or arise out of the Attending Author/Vendor's mis-performance and shall not be required to indemnify Lucky Mountains Events or any of its Indemnitees for any loss or claim to the extent such loss or claim is due to the negligence or willful misconduct of Lucky Mountains Events or any of its Indemnitees.

Photo Release Clause:

The Attending Author/Vendor agrees to give permission to take pictures and/or videos of the event to be used for promotional purposes. The photos and/or videos may be used in media for advertising and promotion. Attending Author/Vendor agrees that any photos, videos, or presentations related to the event can be recorded and provided to paying attendees at a later date. All such media will be owned by Lucky Mountains Events.

IN WITNESS WHEREOF, each of the parties has executed this Agreement, in the case of Lucky Mountains Events by its duly authorized partners, by remitting payment to Lucky Mountains Events with the understanding that all parties agree to what is included in this agreement.
